iii) Black listed firms / Companies / Suppliers / Distributors / Contractors / Sub-Contractor / bidders are prohibited for participation. All bidders shall furnish an affidavit / Certificate that they are neither black listed nor in conflict with Government anywhere in the territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.

5. Conditional, Incomplete and bids filled with lead pencil will not be acceptable.
