No. WUAJ&K/PDO/103/2022, Sealed bids/tenders are invited from well reputed Manufacturers Firms/Sold Distributers/Suppliers registered with Income Tax and GST Department GoP/GoAJ&K who are on active tax payer list for the supply of Lab Equipment (Lot-I), Operational Vehicles (Lot-II), Furniture/ Fixture (Lot-III), ICT Equipment (Lot-IV), Security System (Lot-V) under PSDP funded development project sponsored by Higher Education Commission (HEC), Govt. of Pakistan.

- 2. Interested Firms/Suppliers (registered) can obtain bid documents containing specifications and other terms and conditions from the office mentioned below after submission of written application on original company letter head along with non-refundable tender fee Rs. 3,000/- (Three Thousand only) for each Lot during the office hour on or before March 14, 2022 by 1400 HRS.
- 3. The Single Stage Two Envelope open competitive bidding procedure shall be applied.
- 4. Bids/tenders complete in all respect should reach to the office mentioned below on or before March 15, 2022 by 1100 HRS. Technical bids will be opened on the same day at 1130 HRS by the Project Purchase Committee (PPC) in the presence of the bidders or their authorized representatives in Admin Block of the University. Incomplete and bids received after due date/time shall not be entertained.
- Each financial bid must be accompanied by a Bid Security of 2% (Refundable) of the total bid/value in the form of CDR/Demand Draft/Pay Order in favor of Treasurer Women University of AJ&K, Bagh, without this, the offer shall be rejected being non-responsive.
- 6. The bidders are required to submit their best and final prices matching to the "**Principle of Value for Money**" meaning Quality Products.
- 7. Black listed Firms / Companies / Suppliers / Contractors / Bidders / Distributers are prohibited for participation and All bidders shall furnish an Affidavit / certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
- 8. The Procuring Agency reserves the right to reject all bids or proposals at any time prior to the acceptance of a bid or proposal by invoking PPRA rule.
