




# WOMEN UNIVERSITY OF AZAD JAMMU & KASHMIR BAGH

## Invitation for Bid

No. WUAJ&K/ADP/01/2022, Women University of AJ&K Bagh invites sealed bids/tenders from reputed Contractors/Firms registered with Pakistan Engineering Council (PEC) license renewed for the year 2021-22 (must be up to date upto 30<sup>th</sup> June, 2023) in category C-4 or above (specialization code CE10) for Construction of Boundary Wall and allied facilities to be executed at Bani Pasari, Tehsil and District Bagh under AJK ADP funded development project titled "Acquisition of Land and Construction of Boundary Wall with Women University of AJ&K Bagh".

### Terms and Conditions:-

- Interested Firms/Contractors/bidders can obtain bid documents containing detailed terms and conditions from the office of undersigned during the office hours on or before September 14, 2022 by 1600 HRS after submission of following:
  - Written application on original company letter head
  - Non-refundable tender fee Rs. 5,000/- (Five Thousand only) in shape of demand draft/Pay order/Banker Cheque in favor of "Treasurer Women University of AJ&K Bagh"
  - Original power of attorney on stamp paper worth Rs.100 duly attested by oath commissioner./Notary Public.
  - Original authority letter.
  - Original PEC license must be presented at the time of purchase of bidding document.
- The **Single Stage Two Envelope (SSTE)** procedure shall be applied as per AJK PPRA rules 36(b).
- Bids/tenders complete in all respect should reach to the office mentioned below on or before September 15, 2022 by 1100 HRS. Technical bids will be opened on the same day at 1130 HRS by the Project Execution Committee in the presence of the bidders or their authorized representatives in the office of Director Works, Admin Block of the University. Incomplete and bids received after due date/time shall not be entertained.
- Each technical bid must be accompanied by a Bid Security of Rs 1.550 Million (Refundable) of the total bid/value in the form of CDR in favor of the "Treasurer Women University of AJ&K Bagh", without this, the offer shall be rejected being non-responsive.
- Black listed Firms / Companies / Suppliers / Contractors / Bidders / Distributors are prohibited for participation and All bidders shall furnish an Affidavit / certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
- Bidders shall fill up the BOQs on item wise basis. Bidder has to quote the bid amount in words and in digits and only two digits after decimal point will be considered.
- A pre bid meeting shall be held on September 08, 2022 at 1100 HRS for seeking any clarification in the presence of the firms' representatives in the office of Director Works, Admin Block of the University.
- The Procuring Agency reserves the right to reject all bids or proposals at any time prior to the acceptance of a bid or proposal by invoking rule 33 of AJK PPRA rules, 2017.
- The bid evaluation report and award of contract shall be announced as per rule 35 of AJK PPRA, 2017.
